## VI. **REPORT OF THE FIRE CHIEF** – Fire Chief Don Lombardi

Chief Lombardi reported remotely from Dallas, TX, where he is attending the Fire Rescue International Conference.

The 2025 budget development process is nearing completion. Chief Lombardi highlighted ongoing concerns related to Senate Bill 233 (SB24-233) and Proposed Initiatives #50 and #108. These legislative developments may adversely impact District revenues and present challenges to our budget planning.

## VII. REPORT OF THE TRAINING CHIEF – Division Chief Hutchinson

Active Threat Training is ongoing, with participation from relevant law enforcement and fire agencies in the area.

Planning for a full-scale, multi-jurisdictional active threat exercise has begun. This mock exercise, scheduled for August 2025, aims to be as realistic as possible for all participating agencies.

The 2024-02 Recruit Academy is currently in session with a cohort that includes 17 recruits from West Metro, eight from Arvada Fire, and two from Castle Rock Fire.
